Application Instructions for Manufactured and Mobile Home Plumbing Installation Contractor City of Sioux Falls

General:

Applications cannot be processed until examination has been taken, passed, and all documents have been received and the fee submitted. License processing takes approximately two weeks. If you use a company name, all forms must be completed or issued in the company name. License holder must carry an equivalent or higher state plumbing license.

License Application:

Form must be fully completed, signed, and dated by the owner or officer of the company.

Bond—\$10,000:

We must have the signed original document of your bond. The bond must state you are a manufactured and mobile home plumbing installation contractor. The business name on your bond must be the same business name listed on your application. It is your responsibility to ensure all renewal certificates are forwarded to this office.

Section 121.007 Bond Required.

(a) As a condition of a license, each master plumber, each manufactured and mobile home plumbing installation contractor, and each landscape irrigation contractor shall give and maintain a surety bond in the penal sum of \$10,000 in a form approved by the city. The bond shall be conditioned upon the faithful and lawful performance of all plumbing work entered upon by the contractor within the city and for compliance with all the provisions of this chapter. The bond shall be in lieu of all other license bonds to any political subdivision or government agency. The bond shall be written by a corporate surety licensed to do business in the state.

Expiration:

All licenses expire upon expiration of the bond and will be renewed with the submittal of a new bond or bond continuation certificate.
