# 5. Community Updates

Bill O'Connor gave an update on prime and mortgage lending rates. Prime rates haven't really changed since the October meeting. Short term rates currently are higher than long term rates.

Jeff Nelson talked about the housing market and how the rates are affecting it. Specifically, Jeff said that homes under \$250,000 and over \$1 million are moving, but in between are slower.

Dawn Marie Johnson gave an update on the Sioux Falls School District. Dawn was able to share some demographic updates on the district itself – specifically that between 40 and 50 percent of middle school and elementary students are on free and reduced lunch during the school year. Additionally, the most recent homeless count within the school district was 796 (this is counted differently than traditional homeless counts).

#### 6. Minnehaha County Updates

Kari Benz gave an update on the uptick in homeless families that the county is actively working to house. The county is also working to ensure that shelters are communicating and working together as the city goes into the cold and winter season.

Jeff Nelson commented on updates in Lincoln County. He gave a quick overview of the state looking to build a state penitentiary in the county – explained that the county is limited in its ability to oppose if they chose to do so.

#### 7. City of Sioux Falls, Housing Division, Updates

Logan Penfield gave a quick update on the newly hired Housing Program Specialist, the 2024 action plan process and that the City's application for the State Housing Infrastructure Financing Program Grant was approved.

#### 8. Rental Rehabilitation Program Changes

Logan presented the changes discussed for the Rental Rehabilitation Program. The board then on the motion.

## 9. Amending the Joint Powers Agreement

## 10. \$4 Million Housing Fund Discussion
