c. Charlotte Carver Gallery Tyson/Maren

Committee member Schultz and Maren shared an update on the Carver Gallery Public Art program which was approved by the Planning Department. A call for art will be issued in February and 15-20 pieces installed in the gallery. The show will be juried (jurors still to be selected) and the winning piece will be purchased and accessioned into the City's public art collection. A "People's Choice" award will also be given based on a public voting process and that artist will have a solo exhibition beginning this summer. Maren is meeting with the

mayor to gain insight and support for the project and Tyson and Maren will meet with the city's communications team to create a website and a plan for communicating the program to the public.
