### Questions Received for RFP 22-0131, Digital Signs:

#### 1. How many references are required for the City's RFP for Digital Signs.

The City did not set a minimum required number of references to be included in proposals. Proposers should submit a response that includes references and/or examples of prior work of a similar nature that demonstrates their experience and ability to perform the work. Proposers' ability to demonstrate their experience and ability to perform the work is a scoring criteria worth up to 25 points.

### 2. Do we need to obtain any permit or license to perform work in South Dakota?

Proposers should contact the South Dakota Department of Revenue at 1-800-829-9188 for additional information on requirements to perform business in South Dakota. SD Dept of Revenue will also provide direction on any applicable taxes such as excise tax.

Proposers should also contact the City of Sioux Falls Building Services Division at 605-367-8670 to determine the permitting requirements for the work to be performed.

## 3. Does the City have an installation deadline for this project?

Proposers should provide their lead time for completion of the project in their proposal. Lead time will likely be dependent upon the lead time of the digital sign components and the installers' schedule. The City will negotiate a reasonable deadline with the selected proposer as a part of the final contract once the project is awarded.

#### 4. Will the City accept bids of electronic displays other than Daktronics?

The City prefers to remain with Daktronics as they are the supplier the City is familiar with and has worked with previously. However, the City is willing to consider alternate manufacturers as well. If you would like to submit an alternate proposal along with the Daktronics option, I would recommend that you provide the lead time of the alternate along with the pricing and background information for the alternate as well.

#### 5. Will all the signage go on existing setup?

The only location to use an existing frame and pole will be the Fire Station No. 3 sign. The other two locations do not currently have signs.

#### 6. Do all locations require double sided signs?

Yes, all locations require double signed signs.

### 7. Can you provide details for the existing cabinets?

The size of sign required by our existing pedestal are noted in Section 2.03 of the RFP. Photos will be provided on the City's website under the RFP posting, <a href="https://www.siouxfalls.org/business/rfq/2022/07/rfp--22-0131">https://www.siouxfalls.org/business/rfq/2022/07/rfp--22-0131</a>.

## 8. Please provide existing signage pictures.

#### 9. Will there be any addendums issued?

The City does anticipate issuing one addendum for this RFP. While the City intends to publish the addendum by 5 p.m. on Friday, July 29<sup>th</sup>, it will be published absolutely no later than 9 a.m. on Monday, August 1<sup>st</sup>.

# 10. There are multiple concept designs shown in the bid, is there a specific one that should be followed?

Those designs are an example of the final design. There may be slight modifications once the proposal is awarded. Proposers can use any of those in their mock-ups or design drawings.

# 11. What portion of the current sign located at Fire Station #3 will need to be replaced? Both the white and red panel or just one?

The entire sign will need to be replaced.

# 12. Will the LED sign replace the top or bottom panel of the sign located at Fire Station #3?

The LED will be the bottom portion of the sign.

# 13. Please confirm are the graphics provided in Attachment A panel layouts or LED layouts.

The graphics are for the panel layout. The City will finalize the design upon award of the contract with the selected vendor.

#### 14. Will the LED be full color or monochromic?

Full Color.

# 15. What should the overall height of the signs to be located at Fire Station 5 and 6 be including the base?

The City has not offered an exact required height. The sign should be easily visible to passing traffic in all directions. Ideally, the suggested height should be not less than 7.5' and not more than 9'.

# 16. Can you confirm the style of sign to be placed at Fire Station 6?

The sign should be a monument style the same as provided for Fire Station 5. Fire Station 3 is the only pole mounted sign.
