AN ORDINANCE OF THE CITY OF SIOUX FALLS, SD, AMENDING THE CODE OF ORDINANCES OF THE CITY BY UPDATING THE LICENSES ISSUED BY THE PUBLIC WORKS DEPARTMENT TO SECTION 110.036 OF CHAPTER 110: LICENSES.

BE IT ORDAINED BY THE CITY OF SIOUX FALLS, SD:
