 - a. ArtAbility – Friday, April 17th. Reindl provided update. 43 submissions so far and updated feedback survey. Finnesand suggested providing signage for the accessible entrance on the southwest side of the building and Meier will procure frame to do so.
- iii. *Highlighting Accessibility (Reindl, Mueller, Snyders)*. Reindl provided update. Denny Sanford Premier Center approved script. City Link also reviewed script and next step will be scheduling recording, which they anticipate with take approximately two hours.
Reindl spoke with her contact about voiceover pricing and he advised standard rate is \$1200 per video, but he is willing to offer a package deal. The series will consist of
