- Q2 = 63,300 Ton (22% increase from Q1)

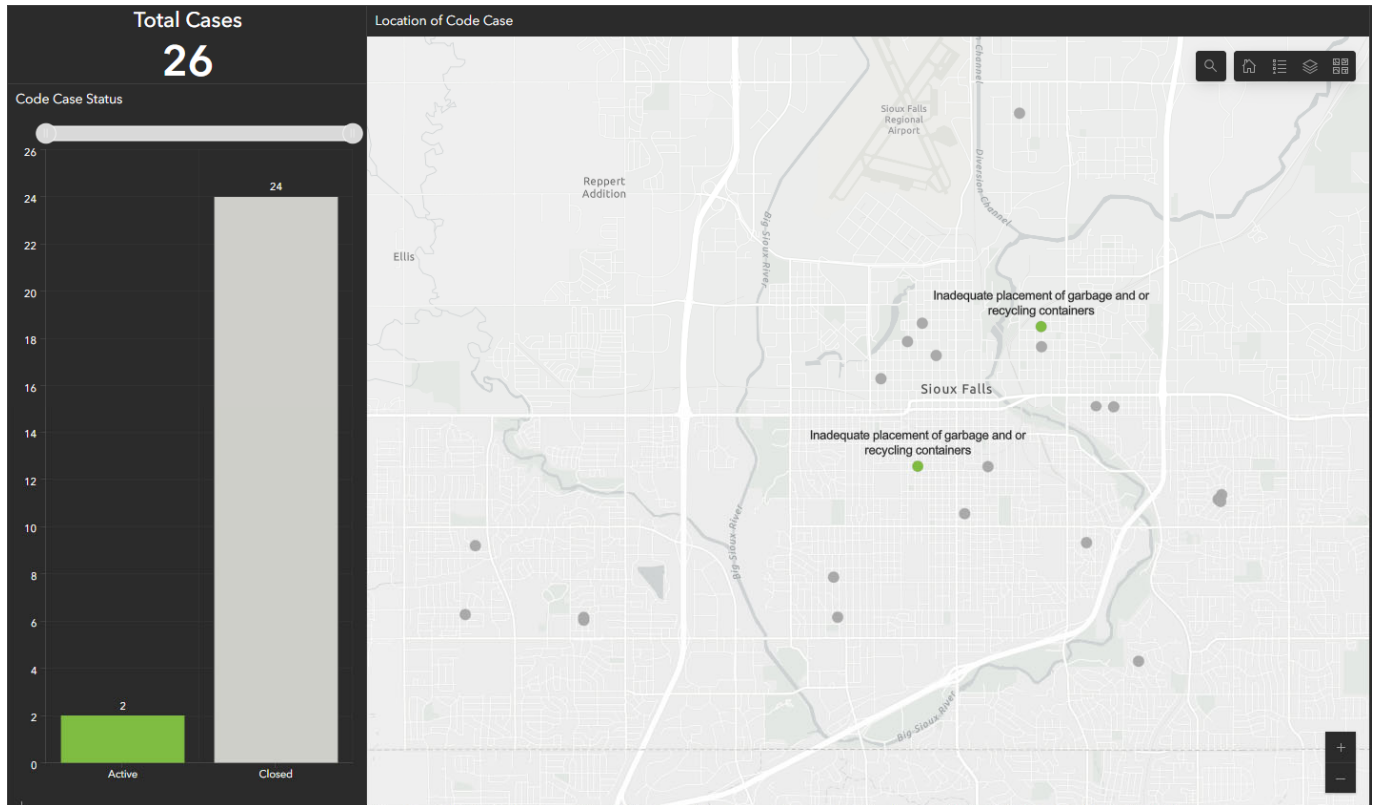
C&D tonnage

- Q2 = 25,600 Ton (25% increase from Q1)

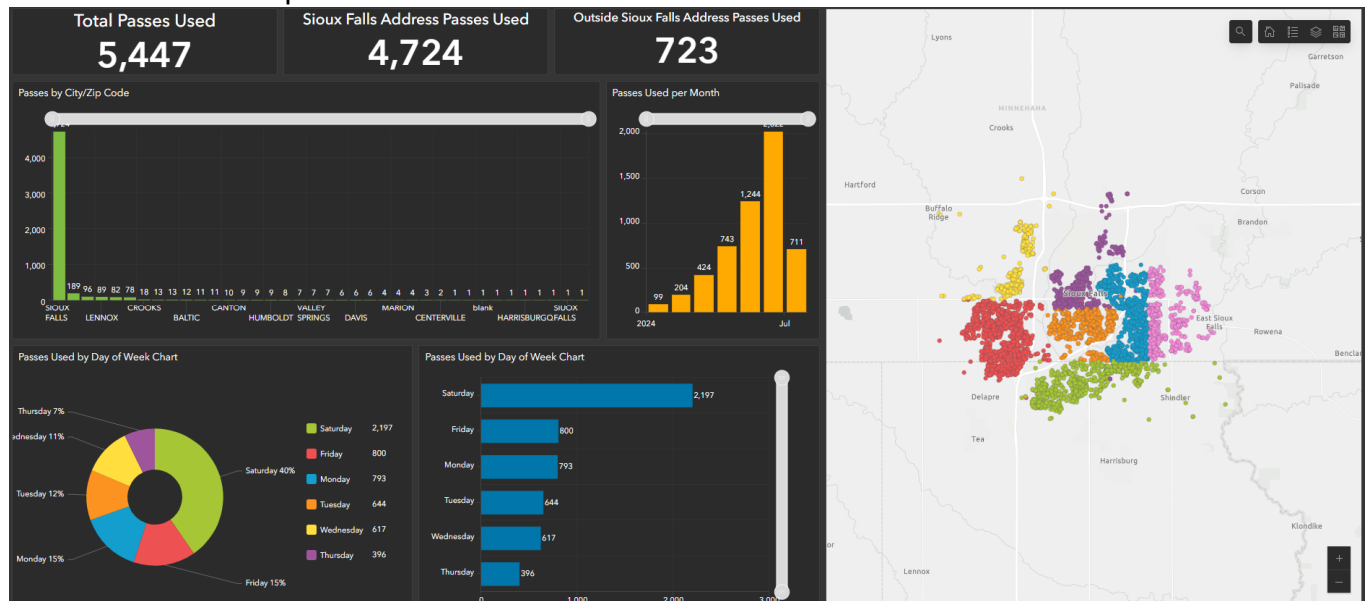
2024 Projects

- **RECYCLING AND WASTE REDUCTION EFFORTS**

- City Comms Team developing marketing messaging for 2024 public outreach
- Site visit at Washinton Crossing
- Food Waste Composting Feasibility Study
 - Contract executed with Burn & Mac
 - Scheduling a kickoff meeting
- Working on test case/pilot project for a multi-family property

Notes

- 6 Mo materials 2024 over 2023
 - Overall up 8.25%
 - 5 Cty - Up 3.3%
 - Trash Up 7.5%
- Recycling Drop-off
 - Served the community for 25 years and beyond
 - Don't want to quit but the culture of a free drop off isn't sustainable
 - Too much garbage
 - Become a dumping area
 - No enforcement from the SF Police Department for illegal dumping
 - Zoning will not approve fencing closer than 35- feet from the curb with setbacks
 - Options suggested
 - Push back to use haulers for their materials
 - Out of town may drop recycling at the landfill
 - Moving it not safe or suitable with room on lot and current traffic
 - Suggested drop-off options with HHW improvements
- Hired an Education Coordinator
 - Due to all the requests onsite and in the community
- Made additional commitments to the BINfluencer NonProfit with their waste diversion education programs and our part in recycling education
